WHAT IS THE PURPOSE OF THE TEST?




ACCESS for ELLs 2.0 measures students' abilities to understand and produce English used within school settings. The four sections of the tests are Listening, Reading, Speaking, and Writing. The test is administered in the following grade level clusters:
Online Grade level clusters.
Grade K Grade 1 Grades 2-3 4-5 6-8 9-12

English language learners will take the test every year until their scores meet the criteria to exit the ESL program. In New Jersey, the students need to reach a **4.5** score to qualify for exit




ENGLISH LANGUAGE LEARNERS

 Garfield ESL population is comprised of 352 students district-wide, which is 8.3% of the total number of students in the district. Sixteen languages are represented. The top seven languages spoken:











Proficiency Growth





This data includes growth based on Garfield Middle School students' ACCESS 2.0 test performance from SY 2020-2021 as compared to school year 2021-2022.






PROFICIENCY GROWTH GRADES K-5
